Re: Debra

In our society only the Judge has the authority to punish a person for a crime. It seems you have guards who think it is their authority and right to add punishment against inmates on a daily bases.

On July 15, 2008 two guards (Deputy Haitht and Deputy Quick) tossed Ms. Debra's cell and disposed of legal papers belonging to her which may not be replaceable. In addition they threw out a jail library book Ms Debra had checked out and now she is being billed for the cost of this book.

Where do the guards get the authority to destroy an inmate's property much less legal documents which is off limits to all jail personal? Is this action authorized by you Warden? There is a Captain in this section who is responsible for the wrongful actions of his two guards named above. The Captain is responsible to you Warden for the Deputies that service under him and you Warden.

Since the appointment of Mr. Broaddus the management of the jail has become worse. Guards are making up their own rules and everyone is being threatened with being written up for any reasons not listed in any rule books. Nurses deny inmates their right to lunch even if they are diabetic. Things are getting out of control not by the inmates but by the staff.

I will be forwarding this letter on to your superiors including the Governor's Office. This is a second letter I have sent you and will qualify for publication on the website at www.court-house.com.

This letter was returned marked not at this address. That really tells how out of control this jail is and it's the Warden who hides in his office and refuses to manage his area of responsibilities.

Dear Mr. Falk,

Your letter needs to be corrected. Debra was treated last week by a real Doctor instead of the incompetent mid wife nurse. Why are the women inmates left to the medical treatment by nurses when the male population is given a real Doctor for their treatment on a weekly basis? Is this to save money or Male Inmates deserver better medical treatment?

The Doctor diagnosed her condition as having incurred Carpal Tunnel in two center fingers of her left hand caused by the 6 months of labor in your kitchen. Spraying scalding hot water 5 hours a day with no break is slave labor of the worse kind. But I doubt you as the "Administive Manager" knows what goes on in this kitchen. The Dr. has ordered her removed from working in the kitchen to prevent further damage to her right hand which is what she had to switch to using in the steam room of your kitchen.

The Nurse assigned to hear Ms. complaints weekly refused to do anything about her injury which now will be a complaint filed with Workmen's Comp. This is against your management of this jail.

While Ms. treated by the Doctor she asked if a hernia belt had received which is over a year late. The Dr went into a back room and found the lost belt which has been there all the time with her name on it. The incompetent Nurse refused to provide this belt to Ms. . Under your term of Discipline as used in your letter you need to learn how it is misused by your staff. Wonder what else is kept in the back room which should have been provided the Inmates under your mismanaged medical care? Why don't you go down and look in this back room if you know where it is.

If you bother the Midwife Nurse too much with complaints of medical needs she will claim you missed a scheduled appointment with her which is a lie. For missing this appointment you will be disciplined and the inmate has no defense against this lie. Retribution is the major forms of Discipline by you're under trained over weight staff. You cross a guard and that guard will make your life miserable and place your safety in jeopardy.

Inmate Debra is to have no additional discipline for this exposure to a complete screw up by this mismanaged jail. The Attorney General is hereby put on notice that this inmate is

to be protected against an out of control staff who actions for the first time is exposed to the public by publication on the Internet.

Very little medial treatment is being given to the Inmates of your jail because the staff administrating this service has no oversight of their actions are there to add punishment against the Inmates. For some reason your staff believes they by their badge have the duty to add punishment over an above the Judges sentence.

Abortions is one service provided by the midwives at your Jail. This means abortions are paid for by the State in your jail. Hence forth no abortions are to be allowed and all pregnancies will be allowed to full term and the guard responsible will be required to pay all future expenses of the child (till 18) while he servers a term in jail for Rape. Consensual sex is not a legal action in a jail by a guard who has supervision over the raped Inmate.

I consider your letter to be mumbo jumbo maybe written by a lawyer as a form letter to hide a complaint.

After you have investigated this complaint I expect a written answer to the wrongs committed by your staff and what correct action will be taken to prevent Workmen's Comp damages being filed against this Jail.

Re: Your letter denying Rape in the library occurred.

Dear Warden Broaddus,

I believe we are playing a game of words. The occurrence of sexual intercourse by a guard and a female Inmate did occur in the library as reported. In your mind it was consensual sex as claimed by the guard and not Rape.

This has to be the only way you can deny any sexual intercourse occurred when if you explained further it wasn't Rape it was consensual.

Sorry but that doesn't make it not Rape. A guard will always claim the sex was forced upon him and it was consensual. The Inmate can claim the sex was ordered and not consensual and she will never be believed by the powers above. An Inmate can be on her back on a table nude with her legs spread apart and this is still not a sign of consensual sex. This position can be as ordered by a guard.

The Office of the Attorney General must investigate this constant violation of sexual intercourse committed by the guards in this prison. Abortions have to be stopped as a cover up by the Correctional Staff in an effort to hide the event and protect the offending guard with no protection for the Inmates from the guards.

When an Inmate becomes pregnant the accused guard is to be given a DNA test and if proven to be the father he is to be held responsible for the entire child support until 18 years old. That is the guard will provide this support while serving a jail sentence for Statutory Rape.

Your staff is so depraved that the guards bring in bubble gum to pay an Inmate to masturbate with all the sounds while in her cell so the guards can watch. All for some bubble gum. This is an example of highly trained staff guarding the Inmates

Next month we will review the harassment of the straight Inmates by the Dikes or Homosexuals who may represent over 50 % of the population. Some Inmates are converted to being homosexual just for self protection.

I expect an answer to this letter from the Attorney General's Office on this complaint. The following tip is provided. Nothing happens in your office that needs your supervision. It's outside of your office that needs your supervision.
